- 1. Terms and Conditions General:** This Application and Terms and Conditions (collectively, the “Agreement”) shall be binding upon and inure to the benefit of any successors, transferees, heirs, and assigns of the parties. Nothing in this Agreement shall be construed to create any duty to, any standard of care with reference to, or any liability to any third party. This Agreement shall be construed and interpreted in accordance with the laws of the State of Ohio, excluding any choice of law rules that may direct the application of laws of another jurisdiction.
 - 2. If Tenant:** If the customer is a tenant, then he or she is responsible for and required to obtain the property owner’s consent as evidenced by a signed “Landlord Consent Form” provided by the Program.
 - 3. Feasibility:** Dominion Energy Ohio and CLEAResult Consulting Inc.’s (“CLEAResult”) review of the design, construction, operation, or maintenance of the energy efficiency measures does not constitute any representation as to the economic or technical feasibility, operational capability, or reliability of the measures. Nor shall CLEAResult, in any way, make such representation to a third party.
 - 4. Responsibility for Implementation:** The customer shall be responsible for all aspects of proper implementation of the measures in this Application. This includes, but is not limited to, obtaining bids, negotiating written scopes of work, paying for materials and labor, and approving the completed product.
 - 5. Customer Eligibility:** In order to be eligible for the Program, including Program rebates, the customer must meet the following requirements:
 - Customer must have an active residential gas account with Dominion Energy Ohio (DEO) and not be eligible for or enrolled in the Home Energy Assistance Program (HEAP) or Percentage of Income Payment Plan (PIPP Plus).
 - Customer residence has not had a home energy assessment or weatherization assistance through the Program in the past five years.
 - Recommended energy efficiency measures (equipment and/or materials) must be installed by a participating contractor at the address listed on the Customer Participation Agreement.
 - The Rebate Application must be filled out completely, signed, and accompanied by copies of dated invoice(s), and received by CLEAResult at the address provided below within one (1) year from the date of the assessment and no greater than ninety (90) days from the date of completion of work.
 - The total, combined rebate amount requested by the customer must be at least \$75, but no more than the \$1,250 maximum in rebates for all installed energy improvements. Rebates may not exceed the total price of the energy efficiency improvement.
 - Customer must meet other Program and Program rebate requirements as acknowledged in the Customer Participation Agreement.
